*** * CATHOLIC AND PARTICIPATING MEMBERS OF A CATHOLIC PARISH * ***

To qualify for participating member of a Catholic Parish rate, children must be baptized and the family must be registered in a Catholic parish. The family must be practicing the Catholic faith through regular Mass attendance and regular use of the parish envelope system. Payment of tuition is over and above that which should go to the support of the Church in the Sunday collection.

1st child (K-8)	\$3150	(10 pmts of \$315)	Cost = \$2.50/hr./child
2nd child (K-8)	\$2100	(10 pmts of \$525)	Cost = \$2.08/hr./child
3rd child (K-8)	\$1600	(10 pmts of \$685)	Cost = \$1.81/hr./child
4th child (K-8)	\$1000	(10 pmts of \$785)	Cost = \$1.56/hr./child

A Pastor Verification Form is necessary for the above scale if not a parishioner of St. Bernadette Church.

*** * NON-CATHOLIC AND NON-PARTICIPATING MEMBERS OF A CATHOLIC PARISH * ***

1st child (K-8)	\$4200	(10 pmts of \$420)	Cost = \$3.33/hr./child
Additional children:			
(K-8)	\$3800	(10 pmts of \$800)	Cost = \$3.17/hr./child

Each family will be assessed a \$450 FUNDRAISING FEE plus \$50 Technology Fee which may be paid by participating in the gift certificate program.

*** * * 3 AND 4 YEAR OLD PRESCHOOL * * ***

3 Yr.Preschool/half-day	\$900	(10 pmts of \$90)	Cost = \$5.14/hr./child
4 Yr.Preschool/half-day	\$1000	(10 pmts of \$100)	Cost = \$4.00/hr./child
4 Yr.Preschool/full-day	\$1500	(10 pmts of \$150)	Cost = \$3.00/hr./child

PRESCHOOL STUDENTS WHOSE FAMILY QUALIFIES FOR FINANCIAL AID MAY PAY NOTHING FOR TUITION. HOWEVER, THE FAMILY MUST PAY THE FUNDRAISING FEE.

Any family with a child in preschool only will be assessed a \$250 FUNDRAISING FEE which may be paid by participating in the gift certificate program.

Lack of finances need not be an obstacle to enrollment in St. Bernadette School. The Bishop's Education Fund (BEF), Scholastic Opportunity Scholarship (SOS), Young Scholars for preschool only, and St. Bernadette Parish have monies available for educational grants to those families with demonstrated need. Information and the necessary forms are available in the school office. Please call to request one.

Recipients of financial assistance from St. Bernadette will be required to make timely payments for their portion of the tuition. In return for tuition assistance, volunteer service will be expected from the parents receiving assistance according to the amount of aid received.

* Household income cannot be more than \$60,000 with one child, but an additional income allowance of \$10,000 is permitted for each student and for each dependent within the same household.

A non-refundable commitment fee of **\$100** per family will be charged in January during the registration process for the new school year. This fee will be applied against the tuition billing.

- o If tuition is paid in full before school begins, deduct \$50 from your total amount due.
- o All families will receive a contract in June with the first tuition invoice. Please fill it out in full, sign it and return it with your first tuition payment due by July 10.
- o A child whose family has not made their first 2 tuition payments (July and August) by the start of the school year will not be admitted to the school.
- o Tuition credit is available for families participating in Market Day. A percentage of your purchase is credited toward the balance of your tuition each time you make a purchase.
- o Fundraising credit is available for families participating in the Script program and the purchase of on-cite-certificates. A percentage of your purchase is credited toward the balance of your fundraising fee each time you make a purchase.
